GCNE also reserves the right to unconditionally reject any application for dealer space for any reason."

Items for sale

Any unethical practices or violation of the rules or conditions of this bourse contract will result in the immediate cancellation of the table privileges without refund of any money that may have been paid and expulsion from the event.

Material for sale must be at least 75% coins, paper money, tokens, bullion, exonumia, numismatic items as determined by the Show Chair's discretion.

An offer for sale of any illegal, forged, or counterfeit item including but not limited to bullion, currency, stamps and historical artifacts without the word "counterfeit" or "copy" prominently and permanently displayed is not allowed. The Show Chair, in its sole discretion, may exclude any item including suspected counterfeits.

Code of conduct

No dealer may exhibit or offer for sale any illegal coins, unmarked counterfeits, forgeries, or copies of any item that is not clearly marked and identified as such. Any violation will result in the immediate suspension of all table privileges and removal from the event.

The applicant assumes all responsibility, financial or otherwise, for all transactions conducted by the dealer or any other person behind his table and recognizes by signing this application that others have the right to rely on this representation as third party beneficiaries to this Agreement.
